

## Accessibility Plan September 2016 – September 2019

### Vision and Values

*Engayne Primary School recognises celebrates and plans for diversity and equality. Equality of access hinges not on treating pupils in the same way, but on taking positive action to redress the inequalities faced by some pupils.*

There are 3 statutory target areas:

3. Improving the delivery of information to disabled pupils.

This plan will include short, medium and long term targets and be reviewed annually.
